**NOTICE IS HEREBY GIVEN** that the West Valley Solid Waste Management Authority (Authority) will hold a public hearing on Tuesday, May 22, 2024, commencing at 5:00 p.m.

The Board will conduct the public hearing to receive comments on the following items:

- 1. Approving Resolution 2024-06 to ratify the Waste Management of South Bay (WM) contractual disposal proprietary rate adjustment effective July 1, 2024.
- 2. Approving Resolution 2024-07 to ratify the West Valley Collection & Recycling (WVC&R) contractual rate adjustment effective July 1, 2024 and approve the Administrative Reimbursements effective July 1, 2024.
